COOPERATION AGREEMENT

Ust-Kamenogorsk, Wrocław

« 23.04 » 2015

RSE "D. Serikbayev East Kazakhstan State Technical University" further named "EKSTU" in the capacity of Rector Temirbekov N. M. acting on the basis of the Charter, on the one hand, and Wrocław University of Technology, further named "WRUT", in the capacity of Rector Tadeusz Więckowski, acting on the basis of the Charter, signed the Agreement as follows:

1. Subject of activity

The subject of the agreement is cooperation in the field of education and science in the framework of the state program of industrial-innovative development (GPIIR-2), promotion of the effective functioning of the system of postgraduate professional education, training of highly qualified specialists with higher education and highly qualified scientific personnel, continuous skills development, integration of professional education and science.

2. Basic directions of cooperation

2.1 Basic directions of cooperation of both parties are:

- 2.1.1 Development and implementation of joint educational programs profiled magistracy on specialties (directions) Mechanical Engineering.
- 2.1.2 Development and exchange of educational literature, teaching materials, preparation of joint scientific monographs, scientific and methodological publications, popular science publications, articles, etc.;
- 2.1.3 Reviewing scientific works and methodical materials;
- 2.1.4 Assistance in the dissemination of information about methodological works, educational programs, publications of the Parties;
- 2.1.5 Academic exchange of experts in the framework of educational and research programs for the implementation of teaching, lecturing, conducting research in areas of mutual interest;
- 2.1.6 Mutual exchange of undergraduates, creating the necessary conditions improving theoretical and practical knowledge for training;
- 2.1.7 Exchange of experience in the organization and methods of training of used educational technology;
- 2.1.8 Joint scientific research, development and other works by function (directions) Mechanical Engineering.
- 2.1.9 Involvement of undergraduates in scientific research work in the priority areas of basic and applied research;
- 2.1.10 Organization and carrying out of joint scientific-practical and scientific-methodological workshops, conferences, consultations and other activities

3. Responsibilities of the Parties

3.1 Parties are obliged to:

- 3.1.1 Facilitate the implementation of joint projects and programs in order, size and methods stipulated by individual agreements entered into pursuant to this Agreement; promptly and fully implement the legal and factual actions necessary for the implementation of joint projects.

- 3.1.2 To share with the legislation at their disposal information resources.
3.1.3 Systematically discuss issues related to the implementation of the areas of cooperation.
1.1.4 To consider the problems arising in the implementation of this Agreement and take agreed solutions.

4. Final provisions

- 4.1 Specific forms of cooperation between the Parties should be stipulated in additional contracts or agreements taking into account preferences of both Parties on all aspects of business.
4.2. This Agreement doesn't entail any financial consequences to both parties.
4.3 Possible financial obligations will be stipulated in the contract, which additionally concluded between the Parties.
4.4 Within the framework of this Agreement both Parties shall protect the rights of intellectual property.
4.5 Any changes or amendments of this Agreement should be presented in additional agreement and become effective upon signature by both Parties, shall be null and void.
4.6 This agreement may be terminated by either Party in a written form to the other Party not later than 45 calendar days before the proposed date of termination.
4.7 This Agreement enters into a force upon its signature and continues until 31 December 2017
4.8 Disputes arising in execution of the provisions of this agreement between the Parties shall be settled by negotiation or by polish court appropriate for Wrocław University of Technology, with application to polish law.
4.9 This Agreement is signed in two copies of the same legal force and kept in one copy for each of the Parties.
